Sir,

With reference to the subject cited above, I am pleased to inform that based on the recommendation of the affiliation committee, competent authority of this Council has approved extension of affiliation of Poornima Institute of Hotel Management for 2020-21 academic year. Due to Covid19 situation, inspection of the Institute was not scheduled by the Council and the recommendation of the affiliation committee was based on the information furnished by the Institute. However, inspection of the infrastructure as well as availability of faculties as per norms may be planned by this Council as and when felt necessary.

You are hereby advised to deposit an amount of Rs.1.50 lakhs towards annual affiliation maintenance charges for the academic year 2020-21 through Demand Draft drawn in favour of NCHMCT, Noida, latest by 17th July 2020. Also, the Institute is required to furnish a bank guarantee for Rs.34.00 lakh with a validity of three years, latest by end of July 2020. It is pertinent to mention here that, out of Rs.100 lakh bank guarantee for 80 intake in B.Sc. HHA to be furnished in three years, your Institute has furnished the bank guarantee for Rs.34 lakh + Rs.24 lakh for Diploma intake during 2019-20 academic year.

Towards signing of the agreement for academic year 2020-21, you are requested to forward to this Council two sets of original agreements as per text of last year already available with the Institute (on Rs.100 Indian Non-Judicial Stamp Paper), duly signed by the Chairman of the Institute. These documents should reach this Council latest by 17th July 2020. After receipt of the same, Council will return one set of duly signed and stamped original agreement to the Institute.
