Sub: Extension of affiliation for 2021-22 academic year.

Sir/Madam,

With reference to the subject cited above, I am pleased to inform that based on the recommendation of the affiliation committee, competent authority of this Council has approved extension of affiliation of your Institute for 2021-22 academic year with existing approved course(s) and intake. Extension of affiliation was subject to inspection of the infrastructure, which could not be organized due to Covid situation. However, inspection of the infrastructure as well as availability of faculties as per norms shall be organized by this Council in due course.

In view of above, you are hereby advised to deposit an amount of Rs.1.50 lakh towards annual affiliation maintenance charges for the academic year 2021-22 through NEFT transfer into Council's account by e-mailing the transaction details to NCHMCT or through Demand Draft drawn in favour of NCHMCT, Noida, latest by 17<sup>th</sup> September 2021.

Also, the Institute is required to furnish the third bank guarantee for balance amount of Rs.32.00 lakh to complete the total BG of Rs.124 lakhs, latest by first week of October 2021. Validity of the new BG should be of three years i.e. up to September 2021. It is pertinent to mention here that, out of Rs.124 lakh, your Institute has already furnished two bank guarantees of Rs.58 lakh during 2019-20 and Rs.34 lakh during 2020-21.

Towards signing of the agreement for academic year 2021-22, you are requested to forward two sets of original agreement as per the text attached herewith, duly typed on Rs.100 Indian Non-Judicial Stamp Paper and signed by the Chairman of the Institute. These documents be forwarded to this Council latest by 17<sup>th</sup> September 2021, so that one set will be returned to the Institute after signing by the Council's authority.
